January 9, 2017

The Mitchell County Commissioners met in formal session on Monday, January 9, 2017 at 8:30 a.m. in the Commissioner's Room of the Mitchell County Courthouse. Present were Chairman Mike Cooper and members Tom Claussen and Jim Marshall. Also present was Terry Bailey, KVSV Radio; Chad Hallack, KDNS Radio; Jason Rabe, Beloit City Administrator; and Heather Hartman, Community Development Director.

The meeting was called to order at 8:30 and the Pledge of Allegiance was recited.

The minutes of the December 30, 2016 meeting and January 3, 2017 waiver of meeting were approved as written on motion by Tom Claussen and seconded by Jim Marshall. Motion carried by unanimous vote.

Carol Torkelson, NCRPC, met with the commission to discuss a change to the Handicapped Accessibility award for the last project of the grant program. She stated that the awarded company had informed her they will not be able to complete the project by the end date of January 31St. Jim's Remodeling was the second choice for the project and it they can find a sub-contractor they will do the job. If not, Kansas Sand will be awarded the project.

The commission passed Resolution 1-17 for Generally Accepted Accounting Principles on motion by Jim Marshall and seconded by Tom Claussen. Motion carried by unanimous vote.

Elected officials were sworn in at 9:00 a.m. Deputy County Clerk Kathy File swore in County Clerk Chris Treaster. Those sworn in by County Clerk Chris Treaster were: Mike Cooper, 2nd District County Commissioner; Jim Marshall, 3rd District County Commissioner; Tami Eck, Register of Deeds; Mark Noah, County Attorney; and Tony Perez, Sheriff.

The commission held a 10-minute executive session for non-elected personnel on motion by Jim Marshall and seconded by Tom Claussen. Motion carried by unanimous vote. Session began at 9:35 and ended at 9:35 with no decisions made in executive session.

The commission discussed a possible 20 hour per week per week position for Jeff Roberg as IT Director.

The meeting was adjourned at 10:35 on motion by Jim Marshall and seconded by Tom Claussen. Motion carried by unanimous vote.

Larry Emerson, Public Works, met with the commission and discussed the ice storm that occurred over the weekend. They will work roads as soon as it is dry enough to do so. Mr. Emerson requested, and was granted, a 10-minute executive session for non-elected personnel on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote. Session began at 9:05 and ended at 9:15 with no decisions made in executive session.

A hearing for Neighborhood Revitalization was opened at 9:30. Hearing no objections from the public and having no one in attendance to discuss the program the hearing was closed at 9:40. Resolution 2-2017 for the Neighborhood Revitalization Program was passed on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

January 23, 2017

The Mitchell County Commissioners met in formal session on Tuesday, January 23, 2017 at 8:30 a.m. in the Commissioner's Room of the Mitchell County Courthouse. Present were Chairman Jim Marshall and members Tom Claussen and Mike Cooper. Also present was Chad Hallack, KDNS Radio; and Heather Hartman, Community Development Director.

The meeting was called to order at 8:30 and the Pledge of Allegiance was recited.

The minutes of the January 17, 2017 meeting and were approved as written on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

The commission appointed Kent Miller to the Convention and Tourism Board on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

Becky Snook, Communications Director, met with the commission to discuss the purchase of a new printer for her office. After discussion the commission approved the purchase of an HP printer in the amount of \$1029 + \$130 approximate installation time on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote. Ms. Snook also requested permission to enter into a contract with ATCI, Hays, for mapping maintenance. This was approved on motion by Mike Cooper and seconded by Tom Claussen at a cost of \$2,500 per year. Motion carried by unanimous vote. The EMS and Fire District repeater has been repaired. Who pays for this repair, just over \$600 was discussed as Ms. Snook felt it was not her department's responsibility. The commission authorized the bill be paid by EMS.

Larry Emerson, Public Works, met with the commission and discussed the condition of the roads following the ice and rain. They are very muddy and sloppy. A couple more loads of salt have been purchased. Mr. Emerson was recently in an accident at Hwy 24 and 230 Rd when a pickup tried to pass him going west as he was turning south on to 230 Rd. There was \$2,200 in damages. Mr. Emerson announced that March 31st, 2017 will be his last day on the job.

Carol Torkelson, NCRPC, brought two amendments for documents pertaining to the Housing Accessibility Grant. The first was for lead paint inspection at no more than \$800 per property and the second a procurement and civil rights document that were approved on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote. The grant expires on January 31st.

Stan Deneke, Noxious Weed Director, had the commission sign his annual noxious weed report and plan which were approved on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote. Also discussed was his progress planting wildflowers in various areas around the county. A flatbed trailer was stolen from the Noxious Weed building and has not been recovered by law enforcement. Mr. Deneke plans to purchase a new trailer and lock it up.

A Neighborhood Revitalization application was approved for Dean Grauerholz in the amount of \$36,000 on motion by Mike Cooper and seconded by Tom Claussen. Motion carried by unanimous vote.

The meeting was adjourned at 9:50 on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

The Mitchell County Commissioners met in formal session on Monday, January 30, 2017 at 8:30 a.m. in the Commissioner's Room of the Mitchell County Courthouse. Present were Chairman Jim Marshall and members Tom Claussen and Mike Cooper. Also present was Chad Hallack, KDNS Radio; and Jason Rabe, Beloit City Administrator.

The meeting was called to order at 8:30 and the Pledge of Allegiance was recited.

The minutes of the January 23, 2017 meeting and were approved as written on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

Carol Torkelson, NCRPC, brought paperwork for the commission to sign concerning the Handicapped Accessibility Grant to finalize the program at the end of January. These documents are part of an earlier portion of the grant that was approved by the commission.

Kelly Hawk, EMS Director, met with the commission and requested an executive session for nonelected personnel for 10-minutes which was granted on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote. Session began at 8:45 and ended at 8:55 with no decisions made in executive session.

Larry Emerson, Public Works, Dale Housh, and Karm Princ met with the commission along with Stuart Porter, Schwab-Eaton, to discuss bridge inspections for the upcoming year. After discussion the commission approved Schwab-Eaton to perform the listed bridge inspections at a cost of \$35,545 except for the Causeway Bridge and the Fisherman's Bridge on motion by Mike Cooper and seconded by Tom Claussen. Motion carried by unanimous vote. The commission approved transfers for 2016 for Road and Bridge as follows: \$200,000 from Road and Bridge to Road and Bridge Special Machinery; \$280,000 from Road and Bridge to Road and Bridge Capital Improvement Fund on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote. Mr. Emerson then requested a 20 minute executive session for attorney-client privilege which was approved on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote. County Attorney Mark Noah was present for the session as was Chris Treaster, County Clerk. Session began at 9:35 and ended at 9:55 with no decisions made in executive session.

The following transfers were approved by the commission for 2016. \$100,000 from the General Fund to Courthouse Renovation and \$50,000 from the General Fund to Courthouse Technology on motion by Mike Cooper and seconded by Tom Claussen. Motion carried by unanimous vote.

The meeting was adjourned at 10:30 on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

The meeting was called to order at 8:30 and the Pledge of Allegiance was recited.

The minutes of the January 30, 2017 meeting and were approved as amended on motion by Tom Claussen and seconded by Jim Marshall. Motion carried by unanimous vote.

Carol Torkelson, NCRPC, brought paperwork for the commission to sign regarding unused funds for the Handicapped Accessibility Grant and also for late contracts.

Nichole McDaniel, NCRPC, met with the commission to see if they would like help with the Heritage Trust Grant or possibly other monies available to tuck/point the Courthouse. The commission agreed that any help would be appreciated.

A Neighborhood Revitalization application was approved for Farmway Coop, Inc in the amount of \$2,750,000 on motion by Tom Claussen and seconded by Jim Marshall. Motion carried by unanimous vote.

The following were appointed to the Convention and Tourism Board: Kyle Peterson, Kim Ellenz, and Lydia Housh on motion by Tom Claussen and seconded by Jim Marshall. Motion carried by unanimous vote.

The following transfers were approved by the commission for 2016 on motion by Tom Claussen: Noxious Weed to Noxious Weed Special Equipment \$10,000; Ambulance, Rescue Squad to Rescue Squad Special Equipment \$14,000; Reappraisal to Reappraisal Capital Outlay \$24,000; Solomon Rapids Fire to Solomon Rapids Fire Special Equipment \$8,500; Tipton Fire to Tipton Fire Special Equipment \$6,500; MCO Fire to MCO Fire Special Equipment \$3,000; Election to Election Technology \$2,500; County Health to County Health Capital Outlay \$60,000; Ambulance to Ambulance Capital Outlay \$5,000; Ambulance to Ambulance Special Equipment \$205,000. Motion was seconded by Jim Marshall and carried by unanimous vote.

An agreement for the Economic Development Director was signed by the commission, the City of Beloit and the Beloit Chamber of Commerce on motion by Tom Claussen and seconded by Jim Marshall. Motion carried by unanimous vote. The county funds this position with ½ mil.

Randy Gengler, Rescue Squad, discussed the possible purchase of a different Rescue Truck. They have located one in Colorado which is a 2001 Ford F550 4x4 with 27,000 miles with most of the equipment needed for \$65,000. They were going to go and look at the truck before possible purchase. Mr. Gengler also stated that they are looking at a new jaw of life as new vehicles are made of harder metals that cannot be cut by their current jaws. He estimated the cost at \$20,000.

The commission called and visited with Erin Jessee, who is the new contact for the Causeway Project. The commission felt that the specifications currently planned for the causeway would be better

Gravel will be tested near the Doug Schmidt place and he has agreed to sell the gravel for \$3.00 yd. Darin Drake resigned his position in the Road and Bridge Department. They have completed the Moss Road gravelling and will do the north end of the Victor Road. Dale Housh requested, and was granted, an executive session for non-elected personnel for 10-minutes on motion by Mike Cooper and seconded by Tom Claussen. Motion carried by unanimous vote. Session began at 9:15 and ended at 9:30 with no decisions in executive session.

Brian Streit, Maintenance, met with the commission and provided two bids for the remodeling project at the Health Department. A bid from Coffield Construction was in the amount of \$9,000 and the other a bid from MiTre Construction in the amount of \$9,242. Commissioner Cooper owns MiTre and abstained from discussion and voting. The commission awarded the bid to MiTre Construction as their bid provided a more comprehensive explanation of costs and materials to be used along with a two-week completion time for the work. Motion to award the bid to MiTre Construction was made by Tom Claussen and seconded by Jim Marshall. Commissioner Cooper abstained from voting and the motion carried by majority vote.

The commission moved to send a letter of support on motion by Mike Cooper and seconded by Tom Claussen. Motion carried by unanimous vote.

The commission made motion to extend their participation in the NCKLEPG and the pay the \$1,500 fee on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

The commission made motion to pay the \$175 fee to KAC for access to the KAC Compensation survey on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote. This service is provided online.

Larry Emerson met with the commission and asked if they had received the correspondence concerning who actually owns the Cawker City Causeway and Bridge. The commission had received the correspondence and, according to research done by John Cashatt on behalf of the County there was supposed to have been a Quit Claim Deed filed to turn this area over, which was never done. The commission felt that due to wording in the original document there is a statement of transfer of land, which would be enough proof for the project to continue.

Chris Treaster, County Clerk, requested and was granted a 10-minute executive session for non-elected personnel on motion by Mike Cooper and seconded by Tom Claussen. Motion carried by unanimous vote. Session began at 10:20 and ended at 10:30 when it was extended 10-minutes on motion by Mike Cooper and seconded by Tom Claussen. Motion carried by unanimous vote. Sheriff Tony Perez and Jail Supervisor Geri McCune met with the commission and they discussed raising the per day charge for housing prisoners from other counties to \$35 per day instead of \$30. Sheriff Perez was going to check with other counties to see what they charge and see if Saline County would still use us for housing if the cost was increased. The commission requested that the Sheriff get the jail staff to clean the facility as it is currently being done by Courthouse staff.

Present were Chairman Jim Marshall and members Tom Claussen and Mike Cooper. Also present were Terry Bailey, KVSV Radio; Chad Hallack, KDNS Radio; and Heather Hartman, Community Development Director.

The meeting was called to order at 8:30 and the Pledge of Allegiance was recited.

The minutes of the February 27, 2017 meeting were approved as written on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

Brian Streit, Maintenance Supervisor asked for a 10-minute executive session for non-elected personnel which was granted on motion made by Mike Cooper and seconded by Tom Claussen. Motion carried by unanimous vote. No decisions were made in executive session.

After reviewing an agreement from Tyco SimplexGrinnell for a monitoring system of the fire alarms in the elevator, Mike Cooper moved to accept this agreement for terms and conditions for the provision of equipment and services in the amount of \$649.00 annual contract. Tom Claussen seconded. Motion carried by unanimous vote. Mr. Streit will complete the necessary paperwork and get it sent in. The contract will run from March 1, 2017 to February 28, 2022.

Work hours of the Maintenance Supervisor was increased from 40 hours a week to 50 hours with no additional pay rate increase, (a salaried position) on motion made by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous vote.

Community Development Director, Heather Hartman visited about some coming events such as Business Appreciation Month in June and the Tree City State Conference being held on March 22nd and 23rd in Beloit. She will be also attending the Dane Hansen Forum. Larry Emerson, Public Works Director and Dale Housh presented the commission with an agreement between Eric Dunstan Trucking and the County. The hauler will transport Mitchell County solid waste from the transfer station to Rolling Meadows Landfill in Topeka. The County will pay \$515. 00 per trip plus any fuel surcharge. The contract shall be for a period of one year beginning with first load hauled on March 7, 2017. Tom Claussen moved to accept this agreement and it was seconded by Mike Cooper. Motion carried for unanimous vote.

The subject of County wide clean-up was discussed and Heather Hartman visited about the \$20,000.00 grant money available for this project. The details are still to be worked out.

Emerson visited about the work being done by the county crew. Phone line has been moved on K Road and low water crossing around Pruitt Farms south of town is being replaced. The wells at the landfill will need to be tested by the end of this year. New gravel has been located on the Doug Schmitt's farm and will be purchased at \$3.50 a cubic yard. The engine on a loader locked up last week. It is 21 years old and has 6,000 hours on it. They are hoping to be able to repair this in the shop.

Kelly Hawk, EMS Director, discussed the Hunter run last week. Information was shared on purchasing additional AED devices so that each emergency response vehicle and City in Mitchell County would have a machine available if needed. There is grant money available for this project and Heather Hartman will help with the application process. Hawk also informed the commissioner he was interviewing for open positions in his department.

The meeting was adjourned at 9:50 on motion by Tom Claussen and seconded by Mike Cooper. Motion carried by unanimous.

Anna Porter, Jewell County Appraiser, provided handouts explaining agricultural land values and state wide comparisons on real, personal & utilities values.
